FDR @ Grand Convention

At the July 14, 2024 Grand Convention, FDR's Corey Bearak delivered his Report as Chief Grand Tribune:

- ► This year the Grand Tribunal over which I presided received no matters to consider, nor any advisory requests.
- ► As I noted in two prior reports, the current process for bringing matters before the Grand Tribunal involves service in person or by mail. This means existing Grand Law does not permit any service (of legal papers) by email in order to commence an action under Grand Law. While I offer no (personal) opinion on any need to change or not change existing Grand Law in this regard, it remains something Grand Lodge may wish to address through legislation.
- ▶ Since the recommendation I made two years ago and again last year remains unaddressed, I again bring it to your attention for consideration. I had recommended clarifying the role of the Grand Advocate. Outside the order similar roles would by tradition, practicality and/or law proscribe that means bar or prohibit, the person whose role is to provide legal guidance and often prosecute and/or initiate and bring matters on behalf of for example, in the case of our order, the Grand Chancellor, Grand Council, or Grand Lodge, not to handle any private matter that would be adjudicated within the order. When such legal advisor represents a private party, that creates an inherent conflict of interest no matter how pure of heart and upstanding such legal advisor might be. If a legal advisor acts in such a manor that presents such a conflict and Grand Chancellor is unable or unwilling to require a legal advisor to avoid such conflict, or replace such legal advisor, the best solution would be to codify the proscription. Thus, I once again bring this to the attention of the body so it can act now or in the future.

If the member or spouse was not buried in a Bayview-Nemo deeded property, the benefits will go to the family upon receipt of a death certificate. A widow remains in good standing by making a one-time payment of \$100.

Grave reservations are \$200 for a surviving spouse at the time of need. A couple can reserve a pair of graves in advance for \$400. The families of all internments pay a cemetery fee of \$50.
